Maximum and Insurance Fees

The following is list of the maximum fees that can be charged to clients for in person/Etherapy services. These fee amounts will be charged to client if CAASS directly bills the client's insurance company¹. Family psychotherapy is provided only on a self-pay basis (see fees below). **Out-of-network (OON) insurance clients are required to pay \$100 time of service.** PLEASE MAKE SURE CAASS IS AN IN-NETWORK PROVIDER BY CALLING CAASS. JUST BECAUSE YOUR INSURANCE COMPANY LISTS CAASS/KENNETH SMITH AS A PROVIDER ON THEIR WEBSITE IS NO GUARANTEE OF IN NETWORK SERVICES, AS THE LISTINGS ON INSURANCE WEBSITES ARE OFTEN INCORRECT.

Self-Pay Fees

Self-paying client's fees are negotiable but will never exceed the maximum fees set above. The negotiated rate varies according to several factors, including client's income, family size, and clinician availability². Self-pay clients will be provided in writing the fees they will pay before services are rendered. Below are the usual self-paying fees.

Paperwork, report writing, additional clinical/counseling services not listed

Paperwork outside of what is required by legal/ethical requirements and what is customary, report writing and additional services not listed above are subject to negotiated fees based on particular services requested and scope of work. Client's will be provided with cost in writing of such services before they are rendered.

Fee Changes and Readjustments

It is CAASS policy to review the fees and may adjust fees twice a year in response to business conditions, inflation, and other factors. Any change in fees are made on the 1st day of January and June of each year. If fees are readjusted, current clients will have notice of any fee changes in writing (email, letter, etc.) at least 90 days prior to the fee change. If clients do not receive written notice, their fees remain unchanged.

1st Appointment/Diagnostic Interview Deposit

It is the policy of CAASS that it may require and charge a \$75 deposit to hold 1st appointments at time of making the appointment, unless prohibited by insurance agreements. The deposit will be applied to any services clients engage in at CAASS³. If the 1st appointment is cancelled without 48 hours' notice to CAASS deposit will be forfeit to CAASS.

¹In-network insurance clients are subject to the negotiated rate their insurers have negotiated with CAASS. Client's with in-network benefits should contact their insurance company to see what the reimbursement rate is. Out of network (OON) insurance clients are subject to balance billing for the full amount that their insurance company does not pay.

²Self pay clients can be provided with a super bill that they may be able to submit to their insurance company for reimbursement. Check with your insurer for details.

³In cases where insurance/other payments exceed the deposit amount, the client will be refunded any excess.
